Noemi Samaniego moved, and Irene Dominguez seconded to approve the financial report ending 3/31/2021 and the expenditures from April 2021. All voted in favor.

Noemi Samaniego moved, and Irene Dominguez seconded to approve the districts workers compensation policy change to Texas Mutual Insurance Company. All voted in favor.

Edward Earwood moved, and Mary Humphrey seconded to approve the Policy and Procedure for Hepatitis B Vaccine Program for Lillian M. Hudspeth Memorial Hospital, Sonora Medical Clinic, and Alvis Johnson Hospice. All voted in favor.

Edward Earwood moved, and Irene Dominguez seconded to approve CARES Act funding purchase of countertops in Lab and Nursing in relation to infection control in the amount of \$24,600.00. All voted in favor.

Noemi Samaniego moved, and Mary Humphrey seconded to approve CARES Act funding purchase of laboratory refrigerators in relation to infection control in the amount of \$10,957.25. All voted in favor.

Mary Humphrey moved, and Irene Dominguez seconded to approve CARES Act funding an COVID 19 Employee Retention Bonus in the amount of \$5000 to full time employees, \$2500 to part time employees and \$1000 to PRN employees as a one time pay run. All voted in favor.

Mary Humphrey moved, and Edward Earwood seconded the need for the reevaluation of the Behavioral Health program established in 2020 and the public need for such a program due to the Covid 19 pandemic and the use of Cares Act funding effective 6/1/2020-6/30/2021. The program will be reevaluated after a period of 12 months. All voted in favor.

Edward Earwood moved, and Irene Dominguez seconded the reclassification of the chiller in relation to the HVAC system in light of the COVID 19 pandemic and use of the CARES Act funding. All voted in favor.

Noemi Samaniego moved, and Mary Humphrey seconded to approve CARES Act funding purchase of the basement HVAC system due to COVID 19 Infection control. All voted in favor.
